RE: Debt Exclusions and the Tax Rate

This office has received a few questions regarding debt exclusions and the tax rate, especially surrounding specific projects currently paid through exclusion.

The Town of Berkley had three items paid through exclusion for fiscal year 2024:

- Somerset Berkley Regional High School debt service
- Town Hall Building debt service
- "Municipal Purpose" debt service

The first two projects are likely familiar to citizens, the final project may require a refresher. The "municipal purpose" exclusion was passed at the ballot box on May 7th, 2022 and again at Annual Town Meeting on June 6th, 2022.

Ultimately, this exclusion raised \$750,000.00 to pay the costs of purchasing two police cruisers for the Police Department, one plow sanders, a water trailer, a lift and a street sweeper for the Highway Department, a new heating system for the Public Safety Building and as to make heating (system) improvements to the Public Safety Building.

In following the table attached, you can see the effect of the retirement of debt on the overall rate of taxation through exclusion. The rate dropped briefly in FY2023, prior to the passage of the aforementioned municipal purpose item. FY2025 includes estimates that show the beginning of the payment of the Bristol-Plymouth debt, the most recently passed exclusion in May of 2024.

To find a specific project's impact to your tax bill in FY2025, use the calculated rate in the attached table. For example, the Bristol-Plymouth Technical exclusion will run a household with an assessed value of \$500,000 around \$90 this year. The same home will see a nearly identical impact (\$90) for the Town Hall building debt. Rates are calculated *per thousand dollars* of assessed value.

The difficulty in producing a single calculator can be seen in the table. Over the previous four fiscal years, the rate required to cover each remaining project has declined. This is possible through the continued increase in the *total value of all real and personal property in town*. As the valuation rises and the amount to be raised remains the same, *the rate must decline*. The agreement, after all, is to cover the borrowing and nothing more. Debt exclusions are not subject to proposition 2 ½ increases, they reflect the amount that must be paid, rising higher or lower to cover that amount.
